#### **Lieutenant General Steven Hummer**

After enlisting in the Marine Corps in 1970, and an honorable discharge as a sergeant in 1973, Lieutenant General Hummer was commissioned following graduation from Albright College, PA, in 1977 with a Bachelor of Science degree in Psycho-Biology.



His assignments in the operating forces included: Rifle Platoon Commander, Company Commander, Battalion Commander and Regimental Commander within 1<sup>st</sup> Marine Division; Chief of Staff, Joint Special Operations Command; Director of Operations, US Forces-Iraq; and Deputy to the Commander for Military Operations, US Africa Command. Lieutenant General Hummer is a graduate of several schools within the Marine Corps University; and earned a master's degree in International Security Studies from the Air War College.

His decorations include Distinguished Service Medal, Defense Superior Service Medal, Legion of Merit with Combat "V", Bronze Star, Meritorious Service Medal, Good Conduct Medal, and other personal awards and decorations.

Lieutenant General Hummer currently volunteers to support veteran service organizations and mentors veterans. He recently completed seminary achieving a master's degree in Chaplaincy. He currently provides chaplain services to the Montgomery County District Attorney's Office and to the Conservatory, an independent living facility in Alden Bridge, The Woodlands.
